# What is CurrentCare?

**CurrentCare** is Rhode Island's Health Information Exchange (HIE). It's a secure network that collects information from practices, hospitals, labs, imaging centers, and other data sources to share crucial patient information with authorized clinical staff.

Everyone benefits when providers access timely patient medical information:

- Save time
- Increase care coordination
